# **PUBLIC HEARING:**

<u>ORDINANCE 724-19</u> AN ORDINANCE AMENDING THE TOWN OF GRAMERCY CODE OF ORDINANCES, CHAPTER 2 ADMINISTRATION, ARTICLE III PERSONNEL POLICY

# **REPORTS**

# 1. MAYOR'S REPORT

Mayor Nosacka welcomed Ms. Barbara Woods to the Board of Alderman. On December 6, 2019, the town received and opened bids for surplus property located at 904 E. Railroad Avenue, Gramercy, LA. Mr. Danny Manual presented a bid of \$22,455.99.

Mayor Nosacka called for a motion to suspend the rules and amend the agenda to accept the surplus property bid. A motion by Alderman Calcagno, seconded by Alderman Louque was unanimously approved to suspend the rules and amend the agenda.

Mayor Nosacka called for a motion to accept Mr. Danny Manual's bid of \$22,455.99 for surplus property located at 904 E. Railroad Avenue, Gramercy, LA. A motion by Alderman Wiggins, seconded by Alderman Calcagno and was unanimously approved to accept Mr. Danny Manual's bid.

The town has met state requirement for Sexual Harassment Training for employees. The Pontchartrain Levee Board is have their Christmas party on December 16, 2019 at 6:30 pm

#### 2. REPORT ON-GOING PROJECT

Mayor Nosacka reported that the new pumps at Dudley Pump Station are running. The engineers will provide a punch list of final items to be completed. On December 3, 2019 the town advertised for bids for the Water Plant ground storage tank interior repainting. A pre-bid meeting the E. Railroad Re-location project has been set for Wednesday, December 11, 2019 and the bids will be due by Thursday, December 19, 2019. The E. Second Street resurfacing is nearly complete.

# 3. REPORTS OF DEPARTMENT HEADS AND DIRECTORS

## A. CHIEF OF POLICE

Police Chief Brent Dicharry reported that the large volume of traffic on Friday, December 6, 2019 was due to a hazardous materials truck accident on I-10 and the state police re-routed traffic. He will be attending the annual Christmas Eve safety meeting with St. James Sheriff's Office, Pontchartrain Levee Board and Town of Lutcher Police Department. Chief Dicharry recommends the waiving of the Open Container and Fireworks Ordinance for the Christmas and New Year holiday.

#### C. CODE ENFORCEMENT

Mr. Ronald Boudreaux reported that he spoke with home owners on N. Pine Street about a roof permit; they will file before the work begins. A resident on S. Hickory Street has removed an abandoned car. He has spoken with another resident on S. Hickory concerning the hazard of a parked car on the side of the street; the homeowner has moved the vehicle.

The press box facility is not to spec with the Recreation's Architectural Design or the Parish's approved plans. We are currently waiting on the Parish to complete the electrical work for the tennis court project. They are waiting on an estimate for fence removal and re-configuration to a shorter rail and gate fence by Park B.

Alderman Calcagno passed out his monthly report.
