# **PUBLIC HEARING**

<u>ORDINANCE NO. 713-18</u> AN ORDINANCE BY THE TOWN OF GRAMERCY, LOUISIANA TO ASSESS A COLLECTION FEE ON DEBTS REFERRED TO COLLECTION AGENCY

No public comments were received on Ordinance No. 713-18. Mayor Nosacka closed the public hearing and continued with regular order of business.

## **REPORTS**

# 1. MAYOR'S REPORT

Mayor Nosacka stated that the New Zion Christian Center Fall Fest was a success. The Gramercy Police Department and St. James Sheriff's Office assisted with security and traffic control. On Reverend Mitchell's behalf, Alderman Coleman thanked everyone for their assistance with the Fall Fest. The meeting with the Corps of Engineers was informative. The Corp presented information so the public would have a better understanding of the Westshore Flood Protection project. LSR will be sponsoring a celebration of Colonial Elementary on December 11, 2018 at 4:00 pm

# REPORT ON-GOING PROJECTS

Mayor Nosacka reported that AT&T will move their service line for preparation of the Railroad Avenue project within the next 30 -90 days. We will soon advertise for the interior repairs of N. Montz Fire Station.

After further inspection and study, the total for the Dudley Pump Station project will exceed the original cost estimate, a final estimate will be provided by Professional Engineering Consultants.

# 2. REPORTS OF DEPARTMENT HEADS AND DIRECTORS

#### A. CHIEF OF POLICE

Chief Brent Dicharry stated that Halloween was successful and no incidents were reported. He is currently working with St. James Vol. Fire Department on safety plans for Christmas Eve. He has ordered body cameras and vests for the officers.

#### B. REPORT FROM EMERGENCY PREPAREDNESS

Lt. Jody Ordeneaux reminded everyone to check the batteries in their smoke alarms.

#### 3. REPORTS FROM ST JAMES PARISH GOVERNMENT

District One Parish Councilman, Alvin St. Pierre, Jr. reported that the budget is currently being worked on and the town will receive \$75,000 for Road Improvements. He has requested a meeting with TB Smith and the Corps of Engineers to further discuss the ring levee protection project for St. James Parish. There will be a Gramercy Recreation Meeting on Monday, November 19<sup>th</sup> at 6:00 pm to discuss the Master Plan; Councilman St. Pierre encourages the Board of Aldermen to attend.

#### 4. REPORTS FROM BOARDS AND COMMISSIONS

#### A. PLANNING COMMISSION

On behalf of Planning Commission Chairman Barry LeBlanc, Mayor Nosacka stated that they continue to communicate with the individuals interested in opening a RV Park on US 61; no final plans have been submitted.

A re-subdivision request was made for 260 S. Elm Street. The property owner would like to sub-divide one large lot into two 5,800 square feet lots.

A motion by Alderman Wiggins to consider allowing the re-subdivision of 260 S. Elm Street was made. The motion failed due to lack of a second motion.

#### **B. GRAMERCY RECREATION DISTRICT**

Mr. Craig Calcagno passed out his monthly report. The Parish has installed a new water fountain by the concession stand and they will begin to winterize the fields. The Board is waiting on a price estimate from Bordelon Pest Control for spraying of ants. New metal benches have been installed. Bike racks are needed near the walking track. The Board is discussing how to proceed with installing one or two new tennis courts.

#### **ORDINANCE NO. 713-18**

# ORDINANCE BY THE TOWN OF GRAMERCY, LOUISIANA TO ASSESS A COLLECTION FEE ON DEBTS REFERRED TO COLLECTION AGENCY

WHEREAS, an ordinance establishing that the Town of Gramercy, Louisiana authorizes the assessment of a collection fee on debts, accounts receivable, costs, fines and fees turned over to a collection agency

WHEREAS, the Board of Aldermen recognizes that there are certain debts and accounts on which the Town has been unable to collect funds due:

WHEREAS, the Board of Aldermen recognizes that there are certain fines, costs and fees ordered by Town which remain outstanding;

**WHEREAS**, the Board of Aldermen recognizes that as the governing authority for the Town there exists a duty to exercise due diligence in collecting public funds;

**WHEREAS**, the Board of Aldermen recognizes that the Town is authorized by state law to contract with a collection agency for the collection of one or more of the following items:

- 1. Debts and accounts receivable including, but not limited to, unpaid utility fees, penalties, interest and other sums due the municipality, as applicable; or
- 2. Court penalties, costs, fines and fees in cases in municipal court in which the accused has failed to appear or otherwise failed to satisfy a monetary obligation ordered by the court;

**WHEREAS**, the Board of Aldermen recognizes that a collection fee will be required to obtain the services of a collection agency to collect these sums, and desires to assess such a fee;

WHEREAS in case any one or more of the provisions of this ordinance shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions of said ordinance, but the same shall be construed and enforced as if such illegal or invalid provisions had not been contained therein. Any constitutional or statutory provisions enacted after the date of this ordinance that validate or make legal any provisions thereof shall be deemed to apply hereto.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Aldermen of the Town of Gramercy, State of Louisiana, in legal and regular and/or special session, acting as the "Governing Authority" of said  $T \circ w n$ , adopt the following ordinance to the Town of Gramercy Code of Ordinances.

BE IT ORDAINED by the Board of Aldermen of the Town of Gramercy, Louisiana:

SECTION I. The Town hereby assesses a collection fee in an amount not to exceed twenty-five percent (25%) of the delinquent municipal debt when the Town has entered into a contract with a collection company or entity for collection of the above listed items. This fee will be added to all sums submitted to the collection agency regardless of age.

SECTION II. BE IT FURTHER ORDAINED that if any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this Ordinance which can be given affect without the invalid provisions, items or applications and to this end the provisions of this Ordinance are hereby declared severable.

SECTION II BE IT FURTHER ORDAINED that all Ordinances or parts thereof in conflict herewith are hereby repealed.

Said Ordinance having been introduced on Monday, October 8, 2018, notice of public hearing having been published on Thursday, October 18, said public meeting held on Tuesday, November 13, 2018 the title having been read and the Ordinance considered, on motion by Alderman Coleman, second by Alderman Calcagno, to adopt the Ordinance, a record was taken and the following result was held.

# A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO THE ANNUAL AGREEMENT WITH THE PONCHARTRAIN LEVEE DISTRICT AND THE COOPERATIVE ENDEAVOR AGREEMENT PERTAINING TO THE CHRISTMAS BONFIRE PROGRAM

WHEREAS, the Town of Gramercy, Louisiana, and the Pontchartrain Levee District desire to enter into an annual Christmas Bonfire program agreement; and,

WHEREAS, the Town of Gramercy, Louisiana, desires once again to comply with the Pontchartrain Levee District Christmas Bonfire program agreement; and,

WHEREAS, the Town of Gramercy, Louisiana, desires to enter into the Cooperative Endeavor Agreement pertaining to the Christmas Bonfire Program.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN, GRAMERCY, LOUISIANA, THAT:

SECTION 1. Mr. Steven T. Nosacka, Mayor, is hereby authorized and empowered to enter into and sign said Christmas Bonfire Program agreement and the Cooperative Endeavor Agreement with the Pontchartrain Levee District, and to pay the Towns' portion of the liability insurance premium in the amount of \$2,500.00.

SECTION 2. That the subject agreements for the Christmas Season 2018 be attached hereto and made a part hereof.

#### **RESOLUTION 32-18**

#### A RESOLUTION AUTHORIZING THE NORTH AIRLINE AVENUE DRAINAGE PUMP STATION PROJECT

WHEREAS, drainage improvements are needed in the North Airline Avenue area, and those improvements will provide drainage relief to that area as well as to facilitate drainage maintenance efforts all along North Airline Avenue.

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND THE BOARD OF ALDERMEN, TOWN OF GRAMERCY, LOUISIANA THAT:

SECTION 1. The Mayor and Board of Aldermen hereby approve the commencement of the North Airline Avenue Drainage Pump Station Project, at an estimated total cost of \$25,000, to be funded from the Infrastructure Sales Tax Fund. SECTION 2. Steven T. Nosacka, Mayor, is hereby authorized to execute any necessary documents related to this

Project.

# **ATTORNEY'S REPORT**

Mayor Nosacka reported that he appeared in court on November 13, 2018 concerning Thomas Ragas property on N. Airline Avenue, Gramercy, LA. The judge has continued the case until March 2019. Mayor Nosacka has requested that Mr. Ragas and his contractors come forward with plans for the building and in January 2019 file for a building permit application.
